

## **TERMS AND CONDITIONS**

1. The promotion, Lockdown Loaded Deal (“the Promotion”) is run by Eclectic Brands (Pty) Ltd t/a Pizza Perfect (“Pizza Perfect”) which Promotion includes a free 50ml sanitiser and face mask (“the mask and sanitiser) with the sale of each Promotion.
2. The Promotion commences on 27 August 2020 and ends on 30 November 2020.
3. Customers use the mask and sanitiser at their own risk. Pizza Perfect, its employees, its franchisees, its suppliers, its agents or promoters cannot be held responsible for any accident, injury, harm, death or loss as a result of the use of the mask and sanitiser.
4. Pizza Perfect does not verify, test for or monitor supplier’s claims regarding ingredient content. Pizza Perfect relies upon its suppliers for correctness of labelling information regarding ingredient content and allergens and can thus not be held liable for any incorrect or incomplete information. Pizza Perfect specifically does not warrant that the use of the mask and sanitiser will prevent any Customer from contracting COVID-19. Please remember that use of the mask and sanitiser is not intended to replace other recommended measures to stop the community spread of COVID-19, such as social distancing, washing your hands and refraining from touching your face.

6. The mask and sanitiser are not designed or intended to prevent, mitigate, treat, diagnose or cure any disease or health condition, including COVID-19/Coronavirus. Any mask and sanitiser used by children should only be used with adult supervision.

Unless the Customer proves gross negligence on the part of Pizza Perfect, Pizza Perfect, its employees, its franchisees, its suppliers, its agents or promoters accept no liability, to the extent permitted by law, for any direct, indirect, incidental, special or consequential injury, harm, death, loss or damage of any kind whatsoever or howsoever caused, arising from the consumption of any product (including but not limited to the mask and sanitiser) or services. The Customer, by entering into any transaction with Pizza Perfect and to the extent permitted by law, agrees to indemnify Pizza Perfect against any loss or damage suffered or liability incurred by reason of the Customer’s purchase of any product or service. In the event that any clause contained herein is invalid or unenforceable, then such clause shall not affect the validity or enforceability insofar as the remaining clauses hereof are concerned.

Pizza Perfect shall not be regarded as having waived or be precluded from exercising any right under these Terms and Conditions by reason merely that we have provided any indulgence to any Customer or we fail to exercise or delay exercising any right we may have, whether the same right or any other right.
9. Pizza Perfect reserves the right to limit the quantity of any item offered as part of the Promotion including but not limited to the sanitiser and mask, online or on any printed or digital promotional advertisements.
