

TERMS AND CONDITIONS

1. The promotional competition, Oom Freddys Legacy Range Promotion ("the Competition") is run by Eclectic Brands (Pty) Ltd t/a Pizza Perfect ("Pizza Perfect"), whose Instagram handle is @pizzaperfect_sa.
2. Participation in the Competition is governed by these terms and conditions ("the Rules").
3. The Competition commences on 1 August 2026 and entries close on 14 November 2026. No entries received after midnight on 14 November 2026 will be considered.
4. Only 15 (Fifteen) winners will be selected.
5. Participation in the Competition constitutes acceptance of these Rules and Entrants agree to abide by these Rules.
6. These Rules shall be governed by and interpreted according to the laws of the Republic of South Africa.
7. Instagram or Facebook are not in any way affiliated or involved in the competition.
8. The Competition is limited to residents of South Africa. In addition, the following persons shall not be eligible to participate in this Competition:
 - 8.1 Directors, shareholders, employees, franchisees of Pizza Perfect;
 - 8.2 Spouse, life partner, parent, child, brother, sister, family member, business partner or associate of any of the persons specified in clause 8.1 above;
9. How to Enter the Competition:
 - 9.1 To participate in the Competition Entrants must adhere to the following:
 - 9.1.1 Purchase any one of the Oom Freddys Legacy Range with a Coca-Cola Product which comprises of:
 - 9.1.1.1 a 30cm Pizza, 20cm Sub, Chicken Wings, Chicken/Beef Burger;
and
 - 9.1.1.2 a Coca-Cola product – can, buddy or 2L;
 - 9.1.2 The Oom Freddys Legacy Range promotion must be purchased through the official Pizza Perfect Online App or Online Ordering Platform, Website or in store.
 - 9.1.3 The products consisting of the Oom Freddys Legacy Range are subject to availability as time of purchase.

- 9.1.4 After the Entrant purchases the Oom Freddys Legacy Range with a Coca-Cola product, the Entrant must send us a direct message on Facebook with a photo of your receipt, name and contact number.
- 9.1.5 Incomplete, incorrect or indecipherable entries will not be accepted.

10. The Prize:

- 10.1 There is a total of 15 (fifteen) prizes to be won in this competition.
- 10.2 The prizes consist of Oom Freddys Legacy and Rugby merchandise; specifications are as follows:

 - 10.1.2 2 x Green and Gold Scarves
 - 10.1.3 1 x Green and Gold Beanie
 - 10.1.4 1 x Red cap
 - 10.1.5 1 x Green bucket hat
 - 10.1.6 2 x Foam hand
 - 10.1.7 Legacy hamper which includes a spice pack, spice sachet, marinade, apron and cap
- 10.3 Prize allocation and collection:
 - 10.3.1 The draw to select the first (1) winner will take place on 8 August 2026 and thereafter 1 (one) winner on 15 August, 1 (one) winner on 22 August and the last 12 (twelve) winners on each proceeding Saturday until 14 November 2026.
 - 10.3.2 The prizes will be awarded to randomly selected winners who have entered on Facebook, using a random number generator. The Promoter will not be held liable if the named prize becomes unavailable or cannot be fulfilled.
 - 10.3.3 The winner is required to verify identity before receiving the Prize.
 - 10.3.4 The winner will be required to collect the prize from the Pizza Perfect store where he/she purchased the Oom Freddys Legacy and Coca-Cola promotion, on a date to be advised by Pizza Perfect after Pizza Perfect has received all information and documentation required from the winner.

- 10.3.6 The decision of the judges will be final and no correspondence or negotiation will be allowed.

- 11.1.2 The Entrant accepts that the Indemnified Parties will not be responsible for any costs, damage or otherwise, howsoever incurred by the winner subsequent to claiming the Prize.
- 11.1.3 Entrants enter and use the Prize at their own risk. The Indemnified Parties, cannot be held responsible for any accident, injury, harm, death or loss as a result of entry into the Competition and/or use of a Prize.

12. POPI:

- 12.1 The winner agrees to the use of his/her name and image in any publicity material.
- 12.2 Any personal data relating to the winner or any other Entrants will be used solely in accordance with current Consumer Protection Act (CPA)/ the Protection of Personal

Information Act (POPI) and will not be disclosed to a third party without the Entrant's prior consent. By entering the Competition, the Entrants consent that the Pizza Perfect may collect, process and disclose the Entrant's personal information, to the extent permitted by law in accordance with the provisions of the POP Act, for all purposes related to carrying out of the Competition.

- 12.3 The Competition is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter or any other Social Network.
- 12.4 The Entrants by taking part in the Competition consents to his/her personal information to be shared with Pizza Perfect's employees, contractors or agents for the purpose of sharing future promotions.

13. General:

13.2 Pizza Perfect reserves the right to cancel the competition without any notice at any time, if deemed necessary in their opinion, or if circumstances arise outside of their control.

13.1 Pizza Perfect reserves the right to amend the terms and conditions of the Competition at any time.

13.2 In the event of such cancellation, all Entrants agree to waive any rights that they may have in terms of this Competition and acknowledge that they have no recourse against Pizza Perfect or the Indemnified Parties.

13.3 Pizza Perfect shall not be regarded as having waived or be precluded from exercising any right under these Rules by reason merely that we have provided any indulgence to any Entrant or it fails to exercise or delays exercising any right it may have.

13.4 In the event of a dispute, the decision of Pizza Perfect will be final and binding and no correspondence will be entered into. In this regard and for further clarity, Pizza Perfect shall be entitled to deal with such disputes (or any failure by Entrants to follow the Rules) in its sole discretion, including that Pizza Perfect shall be entitled to immediately disqualify Entrants from this Competition.

13.5 Unlawful, fraudulent, or otherwise dishonest conduct or any conduct in breach of these Rules by an Entrant and/or their parents/guardians, determined in Pizza Perfect's sole discretion, may result in disqualification from the Competition and ineligibility to win any Prize.
